The tenth day of June2017 was hoped to be a day of supreme entertainment andit was to becherished for long by those who witnessed the Jayaram led show, because stars descended at Panthers, en masse, and star dust kept falling adding glitter and grandeur. Apart from viewing the happenings at Panthers while the Jayaraman, Pisharody led show was on, Iwanted to speak to them on their crafts in which they excelled. The interviews were hastily arranged and intended to be published in our local papers. I could not talk to all 15 artists, I howevermanaged to speak sparingly to the kingpins; Jayaraman, Pisharody, Devassy and Jyotsna, though got well acquainted with all the artists. Having landed in Sydney just a couple of hours ago, after their smashing 'house full' show in Melbourne they hadto have their

midday meals, then to do a full rehearsal on stage, and finally do the real show at 6.30 p.m.I got the only interview they agreed to do, and my interviews were restricted and crisp to anabridged version.

·Jayaraman, a true blue Malayalee showman, was very much chirpy, when I met him and said that he was from a Perumbavoor Brahmin family, and the nephew of the famed writer and Administrator of IAS cadre, Malayattur Ramakrishnan. Jayaram had in him a deep seated wish to become an actor from a young age. He did his higher studies at Sree Sankara College, Kalady; an institution highly leaned to religious

education.He told me that after 200 successful films in his kitty, to a large extent his wish had materialised, but the journey goes

R: You are a Perumbayoor born, Iyer and your ambition to become a star in film world though looked hard and farfetched to reach, you achieved it in style and ease. What helped you to win the glory?; God's blessings, or your Kalabhavan stint, dedication to the core or unflinching wish, or a combination of all of them?

'J: May be I could attribute the success to a combination of all those factors. I took a dedicated interest and wanted to become a movie star by learning from observation and concentrated on learning the tricks of the trade. In silver screen success goes to those who have good looks, ability to

portray characters in true and original style. I did not want to imitate other actorsblindly; I rather devised my own path. I did not hesitate to copy the good features other great actors had successfully adopted. Being a highly competitive cut throat business you should keep abreast of all the threats and perilsvigilantly, foresee and anticipate them. I strictly adhered to that maxim.

R: You are very popular and I can vouch that you are undoubtedly my favourite actor. I view films to keep myself cheerful and happy, and you exactly do that. I had seen almost all your films since 1988, some of them multiple times. Why people like you to this level?

·J: I scrupulously follow the advice given by talented, well trained and experienced Film Directors concerned, never try to override them, and concentrate on what I am doing. They control thefilm presentations the Producers, Directors and story writers wove the magic web, making me as a debonair, humble, simpleton, genuine good guy roles. I continued in that roles film after film. Take for example Rajasenan's movies: Aniyan Bava and Chettan Bava (family car driver from a tharavadi family), Swapna lokathe Bala Bhaskaran (rich man's happy go lucky son), Veendum chila veettu karyangal (As Roy the drama mad Kochu Thomman's darling son). In this film I got some serious acting chance in the second half of the film; Mele parambile aan veedu (Darling educated son of a wealthy village farmer with riches). He wove these characters and built stories on them. That is the scenario with which I am surviving quite well. Go on merrily as far as you can go.

'R: Rajasenan and Sathyan

Moonnampakkam, and Ennale gave you the vital launch pad? You had a vertical take-off. How good was he as a story teller, Director and guiding spirit for you? 'J: He had the uncanny ability to spot talents, and invariably he made stars out of novice beginners. He was always positive in his outlook and encouraged his wards to the optimum. He was a great story writer and one who stuck to details meticulously with no compromises and never took a short cut. In his life of 46 years, he did everything one artist could

'J: I love to do it, With Peruvanam and other top guns willing to accommodate me, I could perform to their expectation, but it is all in the hands of GOD.

R: We can go on and on, but the

time factor is threatening us, so let my wish all good luck come to you in today's show in front of a sellout house and may luck guide you in your film and Melam career in the years to follow. God bless.

'J: it has to happen, though it took some time to realise it.

Every Australian family wants to pay off their mortgage sooner. Do they actually do it?

A mortgage is one of the biggest financial commitments you can make. Find out how you can pay offyour home loan quickly

1. Pay it off quickly

Time is money. There are all sorts of strategies for paying less interest on your loan, but most of them boil down to one thing: Pay your loan off as fast as you can. For example, if you take out a loan of \$400,000 at 5.00 per cent for 25 years, your repayment will be about be about \$2,338. This equates to a total repayment of \$701,508 over the term of your loan.

If you pay the loan out over 10 years rather than 25, your monthly payment will be \$4,242 a month (ouch!). But the total amount you will repay over the term of the loan will be only \$509,114 - saving you a whopping \$192,394!

2. Make more frequent payments

The simple things in life are often the best. One of the simplest and best strategies for reducing the term and cost of your loan (and thus your exposure should interest rates rise) is to make your repayment on a fortnightly rather than monthly basis. How can this make a difference I hear you ask? It works like this: Split your monthly payment in two and pay every fortnight. You'll hardly feel the difference in terms of your disposable income, but it could make thousands of dollars and years difference over the term of your loan. The reason for this is that there are 26 fortnights in a year, but only 12 months. Paying fortnightly means that you will be effectively making 13 monthly payments every year. And this can make a big difference.

3. Hit the principal early

Over the first few years of your mortgage, it may seem that you are only paying interest and the principal isn't reducing at all. Unfortunately, you're probably right, as this is one of the unfortunate effects of compound interest. So you need to try everything you can to get some of the principal repaid early and you'll notice the difference. Every dollar you put into your mortgage above your repayment amount attacks the capital, which means down the track you'll be paying interest on a smaller amount. Extra lump sums or regular additional repayments will help you cut many years off the term of your loan. 4. Get a package

Speak to your lender about the financial packages they have on offer. Common inclusions are discounted home insurance, feefree credit cards, a free consultation with a financial adviser or even a fee-free transaction account. While these things may seem small beer compared to what you are paying on your home loan, every little bit counts and so you can use the little savings on other financial services to turn them into big savings on y o u r h o m e l o a n. There are also "professional" packages on offer for amounts over a certain limit, which can be as little as \$150,000. There are all

sorts of discounts and reductions attached to these packages so make sure you ask your lender about them.

5. Switch to a lender with a lower rate

It may sound like a simple idea but switching out of your current loan and taking out a loan at a lower rate can mean the difference of years and thousands of dollars. If you have a loan that is tricked up with all the features, or even if you have a standard variable loan, you might find that you could get a no frills rate that is as much as a percentage point cheaper than your current loan. However, before you jump the gun, check out what it will cost you to switch loans. For example, there may be exit fees payable on your old loan and establishment fees and stamp

6. Run an offset account

Instead of earning interest, any money you have in your offset account works to offset the interest you are paying on your home loan. For example you may have a mortgage of \$300,000 at 5.00 percent and an offset account with \$50,000 in it earning 3 percent.

Of course, the best sort of offset account pays the same rate as your loan (100 per cent offset).
7. Pay all your mortgage fees and charges up front

Some lenders allow you to add to the amount you borrow instead of coming up with cash for your upfront costs. While this can seem a blessing try to avoid doing this.

Two thousand odd-dollars might not sound like a huge amount but what could you buy with it if it stayed in your pocket?

Five years of dizzying growth have caused house prices to soar in Sydney and Melbourne. The median house

price in Sydney was \$1.1m in the March quarter, and it was \$844,000 in Melbourne during the same quarter, according to the Domain Group.



India finish at top spot in Asian athletics meet

Bhubaneshwar: India won five gold medals on the final day of the Asian Athletics Championships to finish at the top of the standings here on Sunday.

Neeraj Chopra (men's javelin), Govindan Laxmanan (men's 10,000 meters) and Swapna Burman (women's heptathlon) along with the men's and women's teams in the 4x400m relays won gold medals in their respective

Neeraj, who had created waves at the world level, also created a new meet record with an effort of 85.23 meters. Davinder Singh Kang of India took bronze in the event.

Gopi Thonakal made it a 1-2 for India in the men's 10,000m by taking the silver. Jinson Johnson fetched a bronze for India in the men's 800m.

India thus finished with a total of 29 medals. They took the top spot on the medal standings with 12 gold, five silver and 12 bronze. This is the best performance by Indian athletes at the Asian Championships so far.

Continental powerhouse China lagged far behind in second place with a total of 20 medals which included eight gold, seven silver and five bronze.

Kazakhstan were third with four gold, two silver and two bronze for a total of eight medals.

The final day was, however, not without its share of controversy as Archana Yadav, who crossed the line first in the women's 800m final, was stripped of the gold medal for pushing Nimali Waliwarsha Konda of Sri Lanka during the final stretch.

Yadav had produced a powerful sprint in the final stretch to register a time of two minutes and five seconds.

However, following her disqualification, Nimali who posted 2:05.23, was awarded the gold while her compatriot Gayanthika Thusari took the silver with 2:05.27.

Fumika Omori of Japan, who had originally finished fourth with 2:06.50, was upgraded to bronze.

However, the jampacked home crowd at the Kalinga Stadium soon forgot that disappointment as the other Indians made it a day to remember.

Chopra had a slow start to his campaign in the men's javelin with progressively improving efforts of 78.39, 78.54 and 83.06 in the early

He produced 80.99 with his fourth throw, but saved his best for the last, clinching the meet record and the gold medal with his fifth

attempt of 85.23 meters.

B.A. Ahmed of Qatar took silver with a best attempt of 83.70m while Kang managed

"I am not in the best of shape as I had a niggle in my shoulder. I had an MRI test done recently. But I am confident of winning gold at the World Championships next month," Kang told media persons after the event.

Earlier, Burman won the second gold of the day for India with a total of 5942 points in the women's heptathlon.

Meg Hemphill of Japan took silver with 5883 points while India's Purnima Hembram bagged bronze with 5798.

Laxmanan, on the other hand, ran a tactically superb race in the men's 10,000m. He was part of the leading pack throughout the 10,000m final before producing a strong sprint in the final lap of the 25-lap race to leave his rivals far behind.

He registered a time of 29:55.87 while Gopi clocked 29:58.89. Adilet Kyshtakbekov of Kyrgyzstan took bronze with 30:06.65.

This was the second gold medal at this meet for Laxmanan. He had won gold in the men's 5,000m gold as well.

"It was a technical race. I am happy to win a medal. Now the target is the World Championships," Laxmanan said.

In the final of the men's 4x400m relay, the Indians faced a strong challenge from Sri Lanka in the early stages.

Kunju Muhammed, who started off the race for the hosts, could not keep pace with Sri Lanka's T. Dhananjaya and the Indians were in second place behind their fellow South Asians at the first baton exchange.

However, Muhammed Anas, ran a powerful second lap to give India a comfortable lead. Amoj Jacob struggled a bit during the third leg as Sri Lanka's Kalinga Kumarage seemed to make up some of the lost

But Rajiv Arokia produced some scorching pace in the final leg as the Indians won gold with a time of

The Lankans took silver with 3:04.80 while Thailand clocked 3:06.48 to bag the bronze.

In men's 800m, Johnson fetched a bronze for India with a time of 1:50.07.


AMMA, do you see this? Your son Dileep is in police custody

photos of the victim actress.

The Association of Malayalam Movie Artistes (AMMA) placed itself on a crumbling branch as it at once tried to stand behind its 'prodigal son' and embrace its 'daughter' (the victim). The AMMA president's posturing as a preacher and high-pedestal sermonizer, failed to salvage the show for Dileep. As if the whole of the nation waited for an

Hero turns villain as Malayalam actor Dileep lands in police net

Kochi: Putting an end to days of cinema-style uncertainty, the Kerala police on Monday arrested Malayalam actor Dileep in connection with the sensational actress attack case which rocked

Kerala police chief Loknath Behera said Dileep was arrested after the police secured fresh evidence in the

"Dileep has been arrested. We are questioning him," he told reporters. He said no other person has been taken into custody in connection with the case. However, the police reportedly also questioned three other people, including Dileep's friend Nadhirshah, Monday.

"We are very clear about proper treatment. There will be no violation of rights and all legal processes will be followed," Behera said. The police chief refused to share further details.

Dileep was produced before the magistrate court on Tuesday and sent to judicial custody.

Defiant Dileep says 'not scared', actor taken to Aluva sub jail Motive

The 48-year-old actor is accused of conspiracy behind the abduction and assault of the actress, an incident that has sent shock waves in the state.

Though he was arrested Monday evening following his questioning for the second time, the actor was in custody from morning itself.

Though the police had, earlier, suspected alleged benami deals involving Dileep and the victim as the trigger for the attack, the investigators now believe that personal enmity was the motive.

Sources said that the victim's alleged role in actor's personal life angered him and he wanted to settle scores with her. Dileep had admitted that he

was not in good terms with the actress, who survived the horrific

Sources said that the conspiracy was hatched at a hotel in Kochi during a rehearsal for AMMA show, almost three years ago.

The actress, who has worked in South Indian films, was abducted and allegedly molested inside her car for two hours by the accused, who had forced their way into the vehicle on February 17 night and later escaped in a busy area in Kochi.

Mollywood in shock

The Malayalam film fraternity reacted with shock as Dileep was taken into police custody.

Director Vinayan said that Dileep's arrest was a 'scar' on Malayalam cinema. "I hope such reports are wrong. If it is indeed a film artist behind such a heinous crime, it would be heights of shame for Mollywood."

Women in Cinema Collective, however, said that they wanted their colleague, who was attacked in Kochi, to get justice.

Victim's family welcomes arrest

Meanwhile, the family of the actress expressed happiness over the outcome of the investigation.

"We are happy with the outcome of the case. It shows the almighty's touch in the case," they said in a statement. The actress and her family had maintained that they have full faith in the probe by the police despite voices being raised from various quarters seeking CBI probe into the investigation.

Protests

Demonstrations were taken out in various parts of Kerala, and protests broke out instantly after the arrest. A restaurant called 'Dhe Puttu' at

Palarivattom in Kochi, owned by Dileep and friend and film-maker Nadhirshah, also saw protests. Yuva Morcha burnt Dileep in effigy in the Kozhikode. There was a steady flow of people to the Aluva police club too. The DYFI activists vandalized the restaurant's Kozhikode branch late Monday night. They smashed the glass panes and also destroyed the

Though the police arrested Sunil Kumar alias Pulsar Suni, the prime accused in the assault case, six days after the attack, it was only recently the conspiracy angle was cropped up in the police probe.

It's said that Dileep's constant denial of having any links with main accused Pulsar Suni proved suicidal

On April 20, Dileep had alleged blackmail by a man, who claimed that he was a friend of Pulsar Suni in

Later, Dileep's close friend and director Nadhirshah filed a police complaint saying that he had received a call from a friend of Pulsar Suni demanding ransom not to implicate Dileep.

Police had questioned Pulsar Suni for allegedly making phone calls from

jail to threaten and blackmail Dileep and his friend-director Nadhirshah.

13-hour marathon grilling

The arrest came days

after a 13-hour marathon grilling of Dileep and director Nadhirshah at the Aluva police club on June 28. Pulsar Suni arrested six days after the crime, had alleged a conspiracy behind the incident. He said he was commissioned to commit the crime for Rs 50 lakh. A letter purportedly written by or at the behest of Pulsar Suni to Dileep and an audio clip of a telephonic conversation between the accused and Appunni had come out recently, pointing fingers at the actor.

Dileep had repeatedly denied having any links with Suni even while admitting that he was not in good terms with the actress, who survived the horrific night. The actress was waylaid, abducted and allegedly molested by the gang in the car, when she was returning from her workplace.

First breakthrough

The police had come under severe criticism for failing to identify and nail the conspirators. The police stance was that arrests without proper evidence gathering would affect the case adversely and lead to the court quashing the charges.
