Schoolgirl, who fought for ISIS, could face death penalty

Provided by Trinity Mirror Shared Services Limited Credits: Live Leak A German teenager who fled her home to fight for ISIS is likely to stand trial in Iraq, according to diplomats trying to bring her home. If convicted, Linda Wenzel - who was captured in the war-torn city of

Mosul - could face the death penalty. German authorities are understood to be desperately trying to bring her back to Europe, where she could spend a decade in prison if found guilty of joining the terror group.

She vanished at the age of 15 after

falling in love with a fundamentalist she met online, who she later married. German diplomats now say Iraqi authorities have opened criminal proceedings against Wenzel, who is currently in a jail in Baghdad.

The teenager, from the town of Pulsnitz in the eastern German state of Saxony, was seized by Iraqi soldiers after the city fell in July. She had been hiding in an underground tunnel network in the city, which had been under ISIS control since 2014.

Wenzel is one of four German women likely



to be charged with terrorism and membership of ISIS.

She forged a letter from her mum in order to buy a plane ticket to Istanbul, from where she crossed into Syria. The teenager was later smuggled into Iraq. As Germany opposes the death penalty, its diplomats regularly lobby to bring citizens home if they face being executed.

Wenzel married a Chechen fighter who was killed in combat, and when she was captured in Mosul she was carrying a malnourished baby believed to be the couple's child. Her friends in Germany told police that she had suddenly started taking the Koran to school, and wearing longer, more conservative clothing after becoming fascinated with Islam.

Indian migrants exasperated at being denied driver licences

An increasing number of Indian migrants are being denied requests for exchanging their Indian driver licences with an Australian licence, declaring the Indian licence invalid.

Many Indian migrants in Victoria are being told their Indian driving licence is not an "original document" and that they can't drive a vehicle in Victoria.

A number of recently arrived Indian migrants have been told to get a learner's permit as

VicRoads, despite a verification of their Indian licences by the Indian Consulate in Melbourne, is refusing to allow them to take a driving test to exchange their licence with a Victorian driver licence.

Parteek Puri who was working as a pizza delivery driver says he had to quit his job because he was left unable to drive after he applied for a Victorian licence.

Mr Puri says he obtained a verification of his Indian driver licence from the

Indian Consulate in April and submitted to VicRoads. Four months later, VicRoads told him his Indian licence was an original document.

"The licence you presented cannot be verified as the original document and we can't confirm that you held a driver licence in your country of origin," VicRoads told Mr Puri. He has been told to get a learner's permit as his licence was invalid in Victoria.

Subhash Somanathan of Sydney Coveted Bronze medal at the World Tamil Badminton Tournament in Toronto.

Fifth World Tamil Badminton federation tournament held at Toronto in July 2017. Where Subhash Somanathan from Sydney representing Australian WTBF, won the Bronze medal. There were 250 participants from 17 countries across. This was the first time a participant from Australia took part in the event and finished 2nd runner up in the Mixed doubles. It was indeed a proud moment for Subhash and as well as for Australia, subsequently he has been automatically given special privilege to participate next years tournament to be held in Denmark. Previous 4 tournaments were held at Switzerland, France, England and Germany.

Mr. Kandiah Singam, the Founder and CEO, visiting from Switzerland introduced the WTBF and gave a brief history of its activities. He explained, "Last year's 4th Annual World Tamil Badminton Tournament was held in Germany. Professional players from United Kingdom, Germany, Holland, Canada, Sweden, France, Denmark, USA, Norway, Switzerland and Sri Lanka had taken part in the tournament. Tournaments were divided amongst 4 groups: 1) Children players under 12 of age or above; 2) Youth players, 16 years of age and above; 3) Adult players, 20 years of age and above; 4) Senior players, 50 & 60 years of age and above."



Previous tournaments have been held in England, France, and Switzerland. Tournaments are also held in the North and East parts of Sri Lanka to support badminton and encourage the spirit of sport and community in these areas.

The World Tamil Badminton Federation is a non-profit organization founded in Switzerland. It started in April

2013, where the first committee was formed from the players and well-wishers from all over the participating countries. These countries included the UK, Switzerland, France and Canada. Today the committee has grown and now, also includes those from Germany, Holland, Sweden, Denmark, Norway, Sri Lanka, Australia, and the USA.

Amritpal Singh of India, Plays for Sydney Kings

Australia's Sydney Kings has made history today, signing the first Indian player **Amritpal Singh**, to play professional basketball in the National Basketball League (NBL).

Amritpal Singh born on Jan 5 1991, in 'GannaPind' of Jalandhar district in Punjab, grew up by helping his father plough rice fields in a small village 'Fattuwal', in Amritsar district.

Being a Punjabi, Amritpal started with playing 'Kabaddi'- a sport popular in rural India, at an early age, which combines elements of wrestling and rugby.

Soon after growing into a robust frame of 6'11" (Standing Reach 92") and weighing 116kgs, Amritpal switched over to basketball and never looked back. He played in the Japanese Development League for the Tokyo Excellence, playing a key role in a championship in his first year at the club, in 2016.

Amritpal, represented India at the '2016 Asia Challenge' in Tehran and averaged 17.8 points and 10.4 rebounds. Now he is invited by Australian Sydney Kings to join their team for the Atlas Challenge 2017, basketball tournament to be held in China.

Amritpal was formally inducted into the Sydney Kings team today by holding a special function at Sydney's famous tourist spot 'Mrs Macquarie's chair' where team's managing director Jeff Van Groningen spoke about high hopes that they have in Amritpal. He said, "today is a tremendously exciting day to have Amritpal who has won

his place in the team's 11 by his sheer performance. This demonstrates that basketball is a global sport. We take it very seriously when it comes to engaging Indian, Punjabi community from both here and abroad".

The head coach Andrew Gaze was all excited to have the opportunity to coach someone taller than him. Andrew said, "Amritpal is very energetic, fit and mobile. I believe he can add a lot to our team to help us win at NBL title

Amritpal himself spoke about this once-in-a-lifetime opportunity that he is grabbing with both hands. Amritpal said, "I played Kabaddi till 2009 when my uncle introduced me to basketball and since then I have been representing India both in domestic and international tournaments. This is the first time an Indian player has come all the way from India to play with Sydney Kings, hence I appeal all Indians in Australia to come forward and support us".

Sydney's Punjabi and Indian community members attended the event and congratulated Sydney Kings for this unique initiative of inviting players from wider multicultural communities. Dr Surinder Singh told SBS world news, "Amritpal is going to be a role model for all young ones who think of cricket and hockey only these days. We as the community fully support SydneyKings initiative and will be there during rest of the season".

Pros

Reduce taxable income. You can turn an investment loss into a gain by using it to offset your income and pay less tax.

Long-term gain. While negative gearing can provide a financial boost in the short term, you can also take advantage of a long-term capital gain when the value of your investment increases.

Tax deductions. Negatively gearing your investment property also entitles you to a wide range of tax deductions.

Cons

Risk. Borrowing money to fund an investment always carries an element of risk in the form of rising interest rates or in the event



that your property depreciates in value.

Disadvantageous to the economy. Negative gearing can potentially destabilise the economy by encouraging people to borrow more money and by pushing up asset prices

Disadvantageous to property market. Negative gearing can drive up prices on existing houses and it does little to generate new housing supply.

Favours high-income earners. Negative gearing typically benefits high-income earners and makes it harder for first home buyers or low-income earners to break into the property market.
